arrangements of travel health insurance (which is a prerequisite for Bulgarian visa), payment of the visa fees, doing the group application at the Consulate, following up on additional documents requested by the Consulate, ensuring provision of the requested documents from/to the Consulate/participants and handing over the passports to Turkish participants with the issued Bulgarian visas. The contractor will not be responsible for the failure of visa process due to reasons arising from participants' status and/or supporting documents. In case of failure in visa process for one or more participant(s) the Contractor will keep the documents proving visa application and the justified explanation of rejecting visa application issued by the Consulate.

4. In point 4.2.3 Organization of the European Cooperation Day 2015 celebration under the Bulgaria-Turkey IPA Cross-border Programme – "Dance with me across the border", point "d" in bullet 4 is mentioned that "The ensembles should hold a preparation meeting in Sozopol, Bulgaria where the event will take place within 15 days before the event takes place in order to agree upon specific arrangements for the activities, organise the type, order and duration of the songs/dances. For the preparation meeting representatives of Turkish ensemble shall visit the Bulgarian ensemble. Their accommodation, travel and visas should be ensured. The preparation meeting and its contents will be coordinated with the provider and agreed by the CA".

Please, confirm that the Contractor is not responsible for the transportation of the Bulgarian ensemble for that meeting.

The Contractor must ensure transportation of the representative(s) of the local Bulgarian ensemble in case the selected ensemble is from outside of Sozopol. It must be noted that the ensembles will be selected from the cross border region (within the districts of Haskovo, Yambol and Burgas). The transportation arrangement shall be considered accordingly.
